


Fig. 1. RMS on-state current as a function of surge duration; maximum values





Fig. 2. RMS on-state current as a function of heatsink temperature; maximum values




Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values




Fig. 5. Non-repetitive peak on-state current as a function of pulse width for sinusoidal currents; maximum values $t_p \ \leq \ 10 \ ms; \quad (1) \ dI_T/dt \ limit$









Fig. 9. Normalized holding current as a function of junction temperature

Fig. 10. On-state current as a function of on-state voltage





Fig. 11. Normalized gate trigger voltage as a function of junction temperature






Fig. 12. Critical rate of rise of off-state voltage as a function of junction temperature; minimum values
